PresCare's Wills and Bequests program.

As well as making donations during their lifetime, many people choose to acknowledge a favourite charity in their will, by leaving a bequest. A bequest is a special gift of assets or cash that you leave in your will to a person or organisation. After taking care of your loved ones in your will, you might like to also consider leaving a gift to PresCare.

A bequest can assist PresCare in Queensland to support senior Queenslanders well into the future. Recent bequests have enabled us to purchase land for future development and support for our Staff Scholarship program to advance the level of care we are able to provide to our residents and clients.

In order to make a bequest you need to have a will. Making a will is essential, whatever your stage in life. If you haven't made a will, your money and possessions may not be distributed as you wish. You should always seek legal advice to ensure your will is correctly prepared. The Public Trust is able to prepare one for you at no cost to you during your lifetime.

If you already have made a will, you will only need to make a few changes by completing a codicil – a legal supplement to a will, which changes or amends part of that will.

Since we are unlikely to receive your bequest until far into the future, its terms should be as general as possible. Please consult us if you are considering a bequest to avoid any errors or ambiguity.

PresCare Wills clauses are included at the end of this document.

If substantial changes are to be made, we advise you to contact your solicitor to draft a fresh will,

I GIVE DEVISE AND BEQUEATH my parcel of land described as Lot on Registered Plan situated at to PRESBYTERIAN CHURCH OF QUEENSLAND for its general purposes, and I express the wish that the subject matter be paid or transferred to or applied and expended upon PresCare within the said Church.

- 3. Suggested for a gift of residue
(Residue is that portion of a person’s estate which is left over after liabilities, bequests, pecuniary legacies and specific devises have been met from other parts of the estate).**

I GIVE DEVISE AND BEQUEATH the residue of my estate (or twenty-five percent of the residue of my estate or one-third of the residue of my estate as the case may be) to PRESBYTERIAN CHURCH OF QUEENSLAND for its general purposes and I express the wish that the subject matter be paid or transferred to or applied and expended upon PresCare within the said Church.
